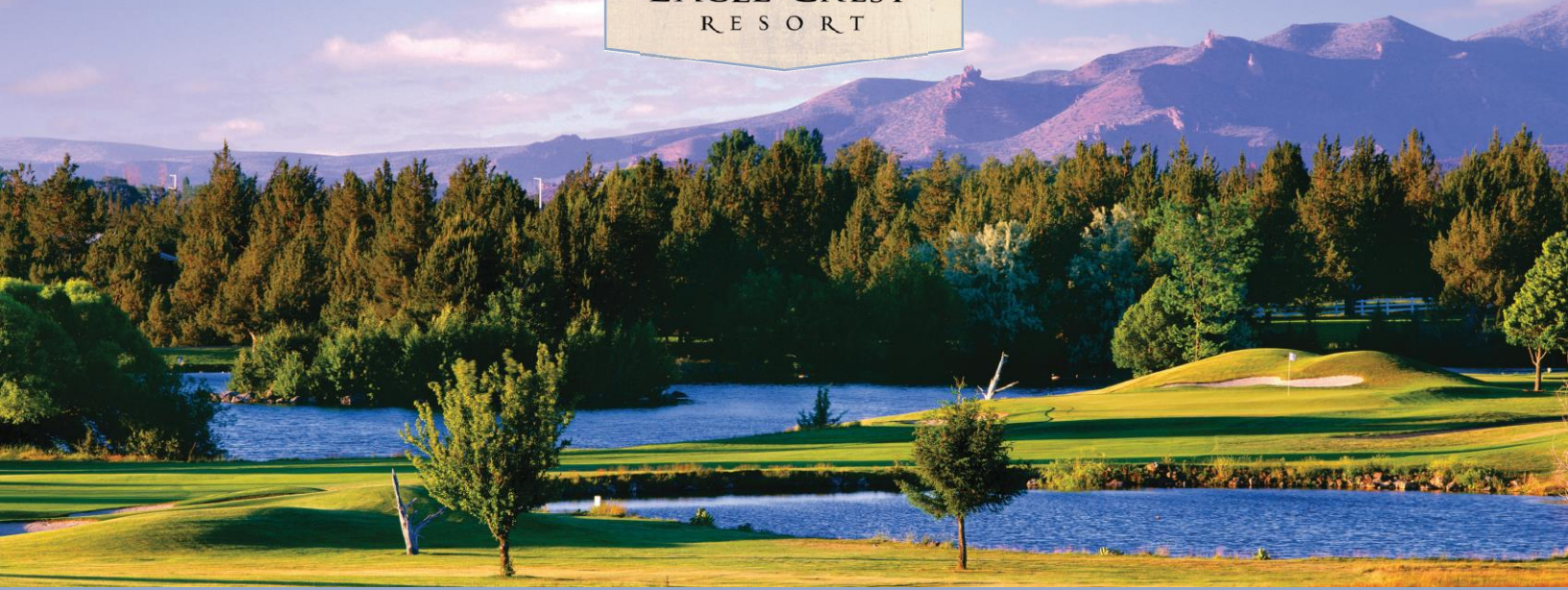

1. Annual Passes are non-refundable, may only be used by the registered users, and may not be reassigned to another person.
2. Annual Passes are valid March 1, 2024, through February 28, 2025. Full payment is due at sign up and will not be prorated.
3. Tee-time reservations may be made 7 days in advance by Platinum Pass Holders over the phone and 21 days in advance online.
4. Tee-time reservations may be made 7 days in advance for Gold, Silver and Bronze Pass Holders over the phone and 14 days in advance online.
5. All Pass Holders will be charged the standard greens fee rate for “no-shows.”
6. All Pass Holders receive one complimentary bucket of range balls per day.
7. Range balls and baskets are NEVER to be taken home, placed in your vehicle, or otherwise removed from the golf facilities.
8. Silver Pass Holders may play in the winter shotguns that begin before noon.
9. All passes unless “walking only” include the use of an electric golf cart on a shared basis. Pass Holders are not entitled to exclusive use and the second seat of a golf cart remains independently controlled by Eagle Crest Golf.
10. Pass Holder agrees to do the following for each use of an Eagle Crest Golf Cart:
 - a) Acknowledge receipt of golf cart(s) in good working order and keep the cart(s) in the same condition.
 - b) Return or refuse a cart if it is not in good working order and inform the Golf Shop immediately.
 - c) Operate the golf cart(s) in a safe manner and comply with all signs, rules, requirements, and directives from Eagle Crest and/or its personnel.
 - d) Always keep golf carts on paths. When a path is not available carts are to remain on maintained turf areas only and 20 yards from the edges of tees and greens.
 - e) Reimburse Eagle Crest for all damages (other than ordinary wear and tear) that occur during the time Pass holder is in possession of or responsible for the golf cart(s).
 - f) Defend, indemnify, and hold harmless Eagle Crest, its officers, agents, parent company and employees from any and all injury claims, including death and/or damage to any person/property arising from or related to the use/rental of golf cart(s).
 - g) Accept full responsibility for the cart(s) and their actions while on the golf course.
11. Guests or playing partners of a Pass Holder shall be charged the appropriate fees for golf cart use.
12. Eagle Crest reserves the right to cancel or modify its Annual Passes at any time without notice.
13. Eagle Crest reserves the right to revoke the privileges of a Pass Holder, without refund, that violates any agreed condition above.
14. There are specific rules for Troon Advantage and reciprocal usage; please see a member of our professional staff for reservation details. Contacting the facilities directly by phone or email is not permitted.
